"South African rings specifically issued within Australia for the South African Million Dollar Pigeon Race are eligible to compete in all VPU Federation races or those raced under VPU rules and raced in that year of the ring for the VPU Produce "

Vote: Unanimous - Passed

From John Dismore for the motion;

Rule 71 – Delete first sentence. Add – "Only one member or partnership can compete from any given premises."

After J.Dismore gave reasons for the motion and others against, J.Share moved that a 2^{nd} motion be addressed seconded C Grech that:

Rule 71 – after the first sentence add – "Each member must be a bona fide flyer in their own right and be a participating member at the VRPU rooms during the racing season. Each member will compete under the Rules of the VRPU and with the Code of Conduct. Each new member will be subject to Rule 5 (b)". Balance of Rule remains as is.

After J Share gave reasons for the 2nd motion, J Dismore supported the 2nd motion and after further debate the question was raised re defining "Bona Fide" which T.Price advised was that if one of the members of a partnership was never at the VPU rooms or could not be seen as an active member then that member was not Bona Fide and any case any complaints from other member/s regarding the validity of a another member in a partnership then that complaint would be dealt with by the Committee to judge the Bona Fide case.

Vote: 32 for 10 against 4 abstained - Passed

Rule 73 – Delete the first sentence. Add – "There shall be a restriction on every member or partnership of the VRPU of 50 birds with the exception of a limit as specified on the Race schedule for a particular Race."
