9.0 Presentation of trophies for 2021 were awarded . Race 1 Serpentine – G . Paterson and Race 2 Serpentine – Huang and Zhang. There were no further racing due to COVID restrictions.

## 10.0 Motions:

The Secretary confirmed that in accordance with Rule 39(1), for a Rule to be changed two thirds of the members are required to vote in favour. In this instance **33** votes were required.

**1. Rule 44 (2b) –** Proposed by NSHC – Delete "seven ordinary members" Add "five ordinary members." Supported by Committee.

Motion from NSHC – 2<sup>nd</sup> J.Share.

J.Share spoke for the motion. Discussions for and against were held. The President called for a vote . Vote taken. For 2 – motion defeated.

2. Rule 99 – Proposed by Craigieburn Club – Delete whole Rule. Add – "All Federations races will race for prize money as follows. For Federation events in the Short series 100% to Sections. For Federation events in the Distance series 50% to open fed and 50% to sections. Section money will be allocated pro rata to the number of birds sent in each current section. Supported by Committee.

Motion from Craigieburn Club – 2<sup>nd</sup> T.Price.

T.Price spoke for the motion. Discussions for and against were held. The President called for a vote . Vote taken. For 20 and 2 proxy – motion defeated.

**3. Rule 104 –** Proposed by the Innerwest Club – Delete – " up to 400km and then a restriction of 30 birds for Federation events greater than 400. Add "for all distances". Supported by Committee.

Motion from Innerwest Club – 2<sup>nd</sup> F.Vellutto.

F.Vellutto spoke for the motion. Discussions for and against were held. The President called for a vote . Vote taken. For 2 and 2 proxy – motion defeated.

**4. Rule 118** – Proposed by J.Davis – Delete "15 positions for prize money" and Add – 10 positions for prize money. Supported by Committee.

Motion from J.Davis – 2<sup>nd</sup> T.Price.

J.Davis spoke for the motion. No further discussion held. The President called for a vote . Vote taken. For 34 and 2 proxy – motion carried.

**5. Rule 133 –** Proposed by J.Davis – Delete "\$200" Add \$300. Supported by Committee.

Motion from J.Davis – 2<sup>nd</sup> T.Price.

J.Davis spoke for the motion. No further discussion held. The President called for a vote . Vote taken. For unanimous – motion carried.

6. Rule 140 – Minute rule from 2021 - Change: "five sections" to "six sections" and after "namely" add "West"
Delete: Those members .....Club
Add: and West section those members of the Innerwest Inv. Pigeon Club. Supported by Committee.

As this Minute Rule was invoked during the 2021 season, a vote was taken and motion For was unanimous – motion carried.
